CHARTER
(Nonprofit Corporation)



The undersigned acting as incorporator(s) of a nonprofit corporation under the Tennessee Nonprofit Corporation Act adopts the following Articles of Incorporation.

- 1. The name of the corporation is **DEVELOP AFRICA**, INC.
- 2. This corporation is a public benefit corporation.
- 3. This corporation will not have members.
- 4. The name and complete address of the corporation's initial registered agent and office in Tennessee is:

- 5. The name and complete address of each incorporator is:

- 6. The complete address of the corporation's principal office is: 307 GREEN VALLEY DRIVE, JOHNSON CITY, TN 37601
- 7. The corporation is not for profit.
- 8. The effective date is immediate.
- 9. No part of the net earnings of the corporation shall inure to the benefit of any officer, director, trustee of the corporation, or any other private person; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for exempt purposes of the corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such

assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

- 9. The purposes for which the corporation is organized are:
 - a. **DEVELOP AFRICA, INC.** is organized as exclusively religious, charitable, and/or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986.
 - b. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
 - c. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.
